## Minutes of the 2012 School District Validation Meeting

## **April 24, 2013**

The legal voters of the town of Peacham are hereby warned to meet at the Peacham School on Wednesday, April 24, 2013 at 6:00 PM before the regular School Board Meeting to transact the following business:

Article 1 Shall the action taken at the school district meeting of the town of Peacham held on March 5, 2013, in spite of the fact that the warning was posted ten days late, and any act or action of the municipal officers or agents pursuant thereto be readopted, ratified and confirmed?

Town Moderator, Tim McKay, called the meeting to order. McKay reminded voters that this is a special meeting of the Peacham School District with only one article warned. He further instructed voters that this meeting is not being held to go over the discussion that took place back in March but solely to consider the warned article. If voters have questions about the school itself, the school board meeting is the appropriate place to voice those questions not at this special meeting.

The moderator reviewed the following rules for the meeting.

- The meeting is for the registered voters of the town. Only registered voters with name tags are allowed to speak. If a visitor wishes to speak the Moderator will ask for the permission of the voters to allow the person to do so.
- Robert's Rules of Order are the basic rules for the meeting.
- Wait to speak until recognized by the Moderator and state your name for the record and speak in a loud voice so that everyone can hear you.
- All remarks are to be directed to the Moderator and must be confined to the merits of the question.
- Debate may be cut off by a motion to call the question and a two thirds vote is needed to do so. Vermont State law prohibits consideration of matters that have not been warned.

The Moderator asked if there were any other announcements before the warning is read. There being no announcements, the Moderator read the warning.

There being no discussion, Dick Browne moved the question. Diana Senturia seconded. A hand vote was conducted and the motion passed.

The Moderator read the article again and briefly explained what people were voting for. A yes vote means that the meeting held on March 5, 2013 is ratified. A no vote means that the meeting in March would not be ratified and we would have to start over.

The Moderator called for a vote on Article 1. A hand vote was conducted and Article 1 passed.

Dick Browne moved to adjourn. Diana Senturia seconded. So voted.

The meeting adjourned at 6:15 PM.
